I can't mention you all here but I do know who you all are and that you are all appreciated.

There is another group who I have not acknowledged previously but I will this time and that's the Friday Club. This is a group of guys who play socially on a Friday in, what is, an event not sanctioned by the club. However they continue to make a significant contribution to the club through their donations. To give you some examples, all the native grasses on No 11 and 18, all

the Gabion Water Fountains and Gabion Posts and many of the new trees on the course have all been supplied by the Friday Club. Thanks so much guys.

To Rob and Jenny thanks again for being the face of our club. Apart from your normal tasks the work you do in welcoming players to the club is a vital role and we are grateful to you both for doing it so well.

To our Club Captains Daryl and Sue thank you both for the work you do. You have to front issues from time to time and you both do it professionally and well.

That's all the thank you's, if I have missed anyone my apologies, it is not intentional and I will put it down to senility.

To all those who have represented the club over the last year congratulations. To Mike and his team well done on winning the Sloan Trophy again. From memory I have congratulated you on seven of the last eight years, that's an outstanding achievement. I'm not sure what your formula is but whatever it is it's clearly working!

I now move to our sponsors. As a club we are so lucky to have such a great group of sponsors. To our major sponsor NBS we are so grateful for your continued support. Greg and his team are great to work with and very supportive of our club. This year we have also welcomed New World Motueka as a major sponsor, thanks for your tremendous support Bruce. New World have been a long term Sponsor of our Twilight Competition and we are very fortunate that this has now been taken over by Coman Construction, welcome to Ben Coman and his team. To our partners; Hamish.Fletcher Lawyers and Bowater Hyundai/Isuzu thank you for supporting our club. We are fortunate to have the support of such a quality Law Firm and Car Dealership. To the many other sponsors who support us, including the new sponsors we have taken on board this year, we thank you immensely. As I have said many times' sponsorship is a two way path. We as a club purchase from our sponsors whenever we can and I again encourage you all to do the same and don't be shy in telling them why you are supporting them, they really do appreciate it. In these difficult times it is more important than ever that we continue to give them our support.

As in previous years we have continued our capital investment and replacement programme. This year we have purchased a John Deere Tractor and a Trimax Snake rough mower. The capital cost of this purchase was \$100,000 and I want to acknowledge the New Zealand Community Trust who kindly contributed \$30,000 towards this purchase. The John Deere tractor, apart from pulling the Trimax, gives us a lot more flexibility with our machinery useage. The Trimax Mower has been an unqualified success as you will have all seen by the quality of the rough. When we finally manage to prize Peter out of the drivers seat the Greenkeepers might even learn how to use it. This year we have also purchased one more golf cart. This brings our fleet to five electric carts, four of which are less that a year old.

The other significant cost this year has been the refurbishment of the interior of the clubrooms. This project started in 2016 when we re-roofed the building and painted the exterior. It continued in 2019 with the construction of the deck. This year the toilets facilities have been renewed, the interior of the clubhouse painted, the fireplace and surrounds replaced, the lighting and wiring replaced, the honours boards replaced and aluminium joinery replaced the ageing wooden windows. Thanks to Barry and his team for overseeing this refurbishment. I think we can now give it the big tick! The number is now

Our membership numbers as at the end of our financial year stand at 440. And as we sit here today that total is 460 This is the highest they have been in my time as president, I don't have figures for prior to my time but I know they were 330 in 2014. I think this increase can be put this down to a number of factors including the flexibility of our membership categories, the way we welcome members to our club and our mass starts and shuffle draws. These all make it easy for members to join and quickly feel part of the club. It is always a bit daunting joining a new club or organisation and the easier we make it the better and I have no doubt that our mass starts and shuffle draws are a competitive advantage for us. And they are also a key factor in our "Friendliest Club in the Top of the South" banner.

Now lets move to the financials. I know Geoff is looking forward to presenting his last set of financial accounts. I won't steal his thunder but it would be very unlike me to not make a couple of comments. Firstly two significant firsts were achieved this year, we exceeded \$200k in subscriptions and \$100k in Green Fees – that is amazing. The second important point I would like to mention is that the Management Committee has now put aside \$100k to be used exclusively in the case of an Adverse Weather Event. We believe this is a prudent risk management approach and while we, of course, hope that we don't have to use it, it is inevitable that at some point we will. Whether the amount we have set aside is adequate we have no idea but the important point is that we now have a fund available. There are two points I want to make in relation to this fund. Firstly when I explained this decision in one of my newsletters I received more positive feedback from members than almost any other decision we have made. Secondly, when I apply for grants now, many organisations are asking if we have a contingency fund for such events and I can now say, yes.

So in summary we have had another excellent year. We are in a position where we have now virtually completed our capital investment and machinery replacement programme. Our machinery would be the envy of most clubs in the country. Our Clubhouse is also now in great conditions and should, baring unforeseen eventualities, require little maintenance in the coming years.

When we take this all into account we are comfortable that we can increase our cost base by employing an Apprentice Greenkeeper and that process is now under way. This extra employee will give Nick and Ian some time and space to tackle the many improvements they would like to make to the course but never get the time too.

We head into another year which is shrouded in uncertainties but we are in great shape to face them head on. And next November we will hosting the New Zealand Freyberg Masters tournament, one of the prestige events on the New Zealand golf calender. This is a great opportunity for us to showcase our course to players from across the country. I spent three days in Wellington last week observing this years event which was held at Paraparaumu. I have no doubt that, with the help of our members, we will host a very successful event.

To all our members let me say that you are served by an incredibly talented group of people who give their time voluntarily to make the club what it is. We expect that with over 400 members there will never be an absolute consensus but they work on your behalf and make decisions so suit the majority and to ensure the longevity of our club. It is important that we all give them our absolute support.

In conclusion it has been a privilege and an honour to be your President over the last eight years. I remember when I took on the job I said I would give it 120% and I think I can say that I have done that. What I didn't realise at that time was that Shona was also signing on, but in her

case her efforts were more in the 150% category. My final thank you goes to her for the support she has given me, especially during the difficult times, and to the support she gives the club.

I know Bryan joins me in saying that we are both thrilled to be handing over the reins to two such capable people as Pete and Bruce. They have our absolute support and we are both happy to support them in whatever way we can.

It is therefore with pleasure that I present this eighth report as your President. I am very happy to take questions from the floor.

2021 Has not been a great year for me personally with almost four months off with my ankle fusion surgery that I am still battling, grrr! On course we have achieved some good stuff which includes the 11th tee completed and just a few weeks away from its first divot, there are also plans to tidy the surrounding areas in place. We had guite the wet winter which I did not see much of as I was away at the time, but Ian and Peter Cederman and the other great crew of helpers keep the course playable even with the rubbish weather. A lot of this is down to the drainage work and physical treatment that we have done to areas of the course over the past few years. I am sure there would have been far more occasions the course would have been closed without this work. The next 12 months are very exciting with two big events included in our already busy calendar with the South Island Masters and Freyberg Masters both being held here a month apart. From our side the main focus will be getting those one percenters fixed up so that we can just present the course at its best when the time comes, so that everyone leaves with great memories of Royal Motueka. Early next year we will be employing a third person on the apprenticeship scheme which I am really excited about, this will allow us to really get our teeth in to the course and take it up to the next level. The need for the extra help has really come from the fact that our management have done such an amazing job in the last five or so years and have filled my shed up with great equipment but not quite enough man power to use it to its fullest, so a big thank you to them. I would like to give a special thank you to Peter Johnson who as gone over and above to set this club up in a great position for the next management crew to take over. The club have been very lucky to have had you at the helm over the past few years I believe the club has a bright future and a lot of this is thanks to your hours of work. Fingers crossed for 12 months of great weather and golfing.

Financial – (Geoff Milnes) Financial report tabled and discussed, another great report with great cash results this is thanks to the committee, greenkeepers, Rob, Jenny & Rachel. Over the last 8-9 years the club has spent \$437,000 on capital equipment, this has been greatly helped by the \$140,000 the club received in funding from various funding organisations.

Ron Noordijk asked where the interest from the adverse event account will go and should we consider leaving it in this account with inflation etc. The committee will consider adding the interest to the AD account or alternatively increase the account by the rate of inflation.

Ron Noordijk queried why junior expenses are \$0 and are we doing enough for the juniors. It would be great to fun a junior programme but it is a matter of getting people that are going to volunteer their time to run a programme.
