Greenkeepers Report – (Nick Van Leuween) -

Another 12 months have flown by with many changes on and off the course. We now have Jack on board as a replacement for Ian who left late last year. Jack has become a great part of the team and we now have three guys on the same page ready to tackle the coming years head on. The past 12 months we have been busy renovating and improving areas of the course such as the drains on 1 fairway. We have now completed our turf nursery on 12 which is away racing and close to getting its first cut. We will use this turf to rebuild some of the underperforming tees such as 4 and 2 ladies. We will remove then re-level and replace with new turf so they will not be out of action for long. The tees have become the worst part of the course hence the reason for committing to this replacement plan. This coming year we will be investing a little more money into fairways and tees to hopefully get us through the hotter months with less heat damage, this will be through the application of wetting agents and better fertiliser and also better grass through re seeding. One of the reasons for this is that our machine replacement programme is in a good space which will allow us to spend a little more on making areas of the course better for longer. I would also like to give a massive thank you to all the volunteers that help keep our course in such great condition. Clubs do not function without these legends. Let's hope the next 12 months is full of sunny days and happy golfing.

Financial – (Chris McGeown)

Motueka Golf Club Inc. has demonstrated a year of growth and stability in its financial performance for the year ending 31 August 2024. A robust increase in revenue streams and prudent management of operational expenses has resulted in a net surplus.

Financial Highlights

• **Income**: Total operating income increased from \$596,878 in 2023 to \$684,161 in 2024, largely due to improved trading income across bar sales, buggy hire, and green fees. Subscription income saw a steady rise, reflecting strong membership engagement and retention.

- **Expenditure**: Operating expenses were consistent at \$534,864 compared to last year's \$534,991. Key expenses in maintenance and development, administrative functions, and standing charges have been managed to align with club needs and operational growth.
- **Surplus**: The club achieved a net surplus of \$92,370, a significant increase from the previous year's surplus of \$6,432. This was primarily driven by increased income and controlled expenses.
- **Cash Flow**: Net cash from operating activities was positive, with \$150,872 generated. After investing activities, which included asset purchases of \$31,797, the club closed the year with a cash balance of \$120,903 and a total of \$380,000 in term deposits, including an Adverse Event Reserve of \$100,000. This cash and term deposit balance positions us well for upcoming commitments and new opportunities.

Strategic Commitments and Liabilities

- A key commitment includes the purchase of a new mower at a cost of \$80,000, expected to support grounds management.
- Current liabilities, including accounts payable and prepaid subscriptions, total \$119,859, with adequate cash reserves to meet obligations.
